- 2019 CAP Month Campaign: The group agreed that the 2019 CAP Month campaign will focus on resilience and what parents can do to support resilience in themselves and their children. It will also present Adverse Childhood Experiences and Adverse Community Experiences in an empathetic way. The campaign will highlight ways for parents and providers to get involved in positive community engagement. Natalie will start working on this campaign, will collaborate with Resilient Yolo, and will ask the CAPC to review the draft when it's ready in a few months.
- In addition, the discussion included the following:
  - Priority topic areas in child abuse and neglect, such as mental health, substance use, domestic violence, and father engagement
  - The need for prevention and upstream approaches and early connections
  - The benefits of a consistent, positive parenting message from multiple agencies
  - Community engagement
  - The need for data-driven approach
  - Evaluation and measuring if anyone is better off
  - Specific recommendations that the CAPC can make:
    - Creation of a Domestic Violence Response Team
    - Updating Domestic Violence County Protocol, which is 25 years old.
